Streamflow and Snowpack Report – Matt Norberg and Kaitlin Boren, Department of Natural Resources and Conservation


 Snowpack: Snowpack in the Big Hole is currently 88% of NRCS median values, however the modeled Hypsome-SWE value is 109% (2004-2023). The modeled snowpack for the basin indicates that the lower elevation snowpack is well


above average, the mid-range snowpack is slightly below average, and the high elevation snowpack is at average.


- Precipitation: Total precipitation in the Big Hole is currently below median values (81%).
- Outlook: The 8-14day outlook predict



New Business

• Jim Hagenbarth: not going to the Legislature for cloud seeding this year. Trying to work within the law and do a pilot either in the Centennial of the Big Hole because of the work Idaho Power is doing.

- Craig Fellin concerned about continued decrease in precipitation and the pressure it's going to put on the river and the on outfitters. Trying to increase the amount of flow to meet the needs of grayling.
 BHWC looking at natural water storage projects in the upper Big Hole. Looking into options and trying to understand the law.
- Lacy Decker, BLM: 30 days is over for decision record for the BLM Maidenrock project. Received one comment and it was positive!
- Brandy Janzen, BLM: RAC starting up in Western District BLM. Submitted proposal to do more restoration work in Dillon area through the bipartisan infrastructure bill. Ramp improvements at Jerry Creek and Divide through may. Looking at ways to help outfitting community, private fishermen, boaters. Migration corridors recreation focus groups coming up in June.

Meeting Topic:

Public Land Water Access Association

Presented by: Haley Sir, Public Access Investigator

- Protecting Public Access in Montana since 1985:
 - "All Montanans are ranchers. Their ranch is the Big Sky ranch and it includes 8.1 million acres of BLM land, 10.2 million acres of National Forest, and 5.2 million acres of state school-trust land. Our brand is the Flying R, which stands for freedom to recreate." – Ron Stevens, Former PLAAI President
 - o 29% of Montana land is public
- What we do: safeguard your access!
 - Maintain, restore, and perpetuate public access to MT's lands & waters
 - o Educate and inform the public about their ownership and public access rights
 - Identify and monitor access issues
 - Work with the public to investigate access issues
 - Complaints via phone, email, and form
 - Research is key
 - Gather evidence
 - Initiate legal action when necessary
 - Less than 10% of cases go to litigation
 - Monitor public land sales, exchanges, and purchases
 - Support laws and policies that benefit public access

 - Promote or encourage trespassing
 - Create, own, buy, or have authority for public ROW
 - Have authority to declare a road open to the public
 - Accept responsibility for an access site's maintenance or legal enforcement
 - Address agency management or travel plans (which do allow for road closures)
- Loch Leven Fishing Access, Park County:
 - Received: Dec. 2020
 - o Access includes a 50ft perfected easement encroached by electric fence
 - Through written conversations with FWP, the electric fence was moved back some of the way, but access is still steep
 - PLWA has asked for the full 50ft w/ additional signage
 - o No further resolution at this time from Region 3 Supervisor or Recreation Manager
- Public Access Investigator:
 - Engage with individuals to investigate and oversee access complaints
 - Undertake the initial interface works of complaints
 - Oversee data management of access investigations
 - Carry out research and outreach involved in investigations
 - Communicate access highlights to the community
 - o Grassroots advocacy and engagement in MT communities
 - Champion public access rights
- Summary of Access Issues:
 - Open Access Issues: 37 in 18 counties
 - Actively Working On: 16
 - Still Needing Verification: 9
 - Oldest Complaint: Feb. 2020
 - o Closed Complaints in 2022: 27
 - o Closed Complaints This Year: 5
- The 1985 Stream Access Law:
 - o The MT Coalition for Stream Access paved the way for MT's Stream Access Law
 - Allows the public to move freely up and down all navigable waters below the mean high water mark
 - Has been challenged in district courts, the state supreme court, and even appealed at a federal level
 - PLWA has defended multiple challenges to the law

Big Hole Watershed Committee, 2023

- A case for MT's stream access:
 - Late 1970s, reports of angler harassment on Dearborn and Beaverhead Rivers
 - 1979, two Butte fishermen (Jerry Manley & Tom Bugni) stepped forward and met with a young Bozeman lawyer, Jim Goetz, in Three Forks
 - Goetz suggested they form a statewide organization dedicated to expanding steam access with his representation (at half the going rate)
 - Tony Schoonen joined shortly thereafter, and the Montana Coalition for Stream Access was born.
 - Two legal victories in 1984 laid the groundwork for stream access in MT: Montana Coalition for Stream Access, Inc. v. Curran and Montana Coalition for Stream Access, Inc. v. Hildreth.
 - Within months of the Curran and Hildreth decisions, nine bills concerning stream access were introduced to the 1985 Legislature.
 - Tony Schoonen & Jerry Manley (future long-time members of the PLWA Board of Directors) were assigned to a sub-committee to draft the law.
 - Legislators, landowners, stockmen, farmers, recreationalists, hunters, anglers, and many other organizations worked together to develop House Bill 265 - which became the Stream Access Law we know today.
 - The next year, Gene Hawks, a former Gallatin USFS Supervisor, founded PLAAI. Membership with the Stream Access Coalition overlapped
- Ruby River case: The forefront of stream access conflict:
 - Involved barriers and illegal fences that blocked access at several bridges for two decades
 - Landowner advertising "private water... lease[d] for the exclusive use of our guests"
 - o 2004 PLWA filed suit
 - 2005 Nearly 200 anglers and recreationalists turned out to float the contested stretch of the Ruby River (Stream Access Celebration Day Float)
 - 2008 the District Court ruled in favor of PLWA, a decision what was affirmed on appeal to the MT Supreme Court
 - Precedent setting case defending public access against well-funded, aggressive challenges
- 2009 Bridge Access Law:
 - Hundreds of river miles in MT flow through private property, with the only access point sometimes being a public bridge crossing (also causing them to be a battleground for stream access).
 - Up until 2000, went off Attorney General opinion stating a bridge and its abutments are part of that public highway.
 - Ruby River case provided the impetus in the legislature to push for 2009 Bridge Access Law, allowing stream access at public bridges for legal recreation.
- Other notable wins:
 - STATE SCHOOL TRUST LANDS
 - Prior to 1988, permission was needed to recreate. PLWA filed suit against the State Public Land Department to open lands to the public
 - BOADLE ROAD/JONES BRIDGE
 - Area currently provides access to Pishkun Lake Wildlife Refuge, 918k acre Rocky Mountain Front Conservation Area, Tunnel Lake, and several MT State sections
 - SALMOND RANCH ROAD
 - Thousands of acres were opened up allowing you to walk from Rocky Mtn Front to Flathead Lake on public lands.
 - PROTECT HABITAT MONTANA

- AIRS Program:
 - First program of its kind to address access issues across MT
 - Provide a central point to register access complaints
 - Collect data to learn about the volume, type, and location of access issues we're facing
 - Track the evolution of access issues
 - Increase efficiency in investigations and resolutions

Big Hole Watershed Committee, 2023

- Become an access ambassador or volunteer:
 - PLWA's Access Ambassador program brings the public together to highlight important public land and water issues and connect people with access issues they care about.

- Public Access Investigation Certificate Program:
 - o 8-hour course to educate volunteers to advocate for public land and water access rights

 - Develop skills required to bridge gaps between public and private landowners while safeguarding & enhancing access
 - o Create partnerships between organizations & communities that care about public access
