
Meeting Minutes







 Conditions





Snowpack (UMRB) for WY 2026






Precipitation (NWCC) for WY 2026: 88% of average (1991-2020)


- Climate Outlook (NOAA):
 - Outlook: The 8-14 day outlook predicts slightly below normal temperatures and slightly above normal precipitation.
 - Seasonal Outlook: The seasonal outlook predicts slightly below normal temperatures and slightly above normal precipitation.
 - o ENSO Conditions: La Niña is favored to continue into the Northern Hemisphere winter, with a transition to ENSO-neutral most likely in January-March 2026 (61% chance).
- U.S. Seasonal Drought Outlook: Moderate to severe drought persists in our watershed.

Meeting Topic:

Coolidge: The Life Behind the Ghost Town

Cultural and Archeological Resources at the Elkhorn Mine and Mill

Presented by: Ayme Swartz and Ciara Pares Kempf

Background: Once a bustling mountain company town, Coolidge comes to life again through newly uncovered photographs and personal stories of its former residents. Presenters Ayme Swartz and Ciara Pares Kempf will explore what life was like for the people of Coolidge during its 1920s heyday and share insights into a new interpretive plan designed to enhance the visitor experience at the ghost town. Ciara, based in Anaconda, specializes in uncovering the untold stories and underrepresented communities of the West and is an active member of the Big Hole Valley Historical Society. Ayme serves as a Historic Preservation Commissioner for Silver Bow County.

Welcome Back to Coolidge

- Reopening mill site to visitors in 2026
- Establishing a self-guided walking tour
- Public input and assistance in the future

Reclamation Work

- Begun in 1980s to address toxic heavy metals and arsenic runoff into the watershed
- Removed toxic tailings piles, capped ponds, stabilized streambanks
- Currently stabilizing the mill footers, reclaiming waste dirt, stabilizing the mine adit entrance

Elkhorn Discovery

- 1873 by Mike Steel & F.W. Pahnish
- Named by Bill Roe who found shed horns
- Silver camp, popularity crashed following the demonetization of silver in 1892
- Renewed interest beginning in 1903

W.R. Allen Gets Big Ideas

- 1911: William R. Allen (right) buys 1600 acres
- S.W. Hall encourages delusions of grandeur
- 1916-1919 Allen builds a railroad, electrical, and telephone infrastructure

A Quick Rise and a Sharp Drop

- Receivership 1920s, reorganized 1925
- Flood 1927, reorganized 1928
- Great Depression 1929
- In a coma 1930s-1952

When the Camp was Hopping

- Heyday 1921-1929
- 250-300 residents
- Entirely white
- Majority male
- 50-60% US citizens
- 20-30 children at most

What was there to Do in Coolidge?

• "There is nothing to do here but lay around and it sure gets tiresome. There is no place to go- this will be a good place for you to keep me home as I haven't left the shack since I've been here." – letter from Harry Renz, miner at Coolidge, to wife Jessie Shafer Renz, 1922



Wild Times in the Old Town


- "A school benefit dance was given at the school house New Years night. Mr. Richards, the mine foreman, brought up and installed his radio and we all danced to Los Angeles music. Refreshments were served during the evening and tickets sold resulted in a substantial sum." – Big Hole Basin News, January 8, 1925
- "There is going to be a dance tonight. The train comes up (from Wise River) you see and they will bring a crowd from below." Letter from Harry Renz, miner at Coolidge, to wife Jessie Shafer Renz, 1922
- "Note: Wise River wives who let their husbands come to Coolidge unattended on dance nights. We cannot possibly be responsible for stolen or damaged property." – Doings of Coolidgeians, Big Hole Basin News, March 26, 1925



<u>Landmarks in Town Today</u>

- Tyro House: "Mr. Frank Tyro went out on December 17th and he and Mrs. Tyro (nee Muriel Paddock of Bannack) returned the 23rd. The Coolidgeians gathered together and gave them an old-fashioned charivari, after which a pleasant evening of music, cigars, and candy was spent at the Tyro's new bungalow." –
 Doings of Coolidgeians, Big Hole Basin News, January 1, 1925
- The Sauna: In the 1920 census, 25% of Coolidge's population came from a Nordic country where sauna use was prevalent.
- The "Schoolhouse" (pictured above right)
 - o It's NOT the schoolhouse ... so what is it?
 - Cold storage for food/meat?
- The Elkhorn Mill:







- Ore Chutes
- Assay Office
- Stables
- Mysteries we're still unraveling:
 - O What did this thing (right) do?
 - O What did this machinery (below, left) operate?



This mysterious pile of toothed metal (below, left) was originally compressed into a thick sheet, and has delaminated over time. But what the heck is it?



- OBoxcar-like structure, about 6 feet wide by 24 feet long (below, right)
- Probably stood up like a chimney (but surprisingly intact if it fell over)





- Has several large
 - opening, not just the single opening you'd expect at the bottom for a ventilation shaft.
- Sits a few hundred yards to the north of the mill site, near the compressor pad
- Possibly for boiler ventilation?
